## Capitol School Foundation RV parking 2017 Football Season

**Location:** Adjacent to historic Capitol Park at 2828 Sixth Street located at the end of University Blvd. in downtown Tuscaloosa. Our parking lot is the beginning of the "River Walk" that extends along the Black Warrior River to the campus of The University of Alabama.

**Donation: Benefits of free parking for members of "Friends of International Library"**  
\$150 for single game  
\$800 for SEASON PASS for 7 games.

**Purpose:** All donations are tax-deductible as gifts to **Capitol Foundation** for Library

**Times:** Arrive as early as 4:00 p.m. on Friday and depart as late as 5:00 p.m. on Sunday

**Types of spaces:** There are 5 spaces available on an asphalt parking lot, two additional spots on school driveways and 3 more in another school parking lot. Owners of RVs in groups may reserve adjacent camping spaces. Choose one member of the group to serve as Coordinator who can email us all the names of persons in the group and the size of the RV. Sixth Street is a dead-end street that ends at our block. **All RVs must be self-contained as hook-ups are not available.**

**Size of spaces:** Sizes of spaces vary to accommodate 20' x 40' up to 45'. All tents and awnings must fit within the spaces provided and not intrude on other camp sites. Spikes or stakes cannot be driven into the parking lot.

**Applications and Payment:** Please print out application and mail it to the school with payment included to **The Capitol Foundation**. Campers must read, sign, and submit the Release Liability Form upon arrival at the campsite. Please complete the information forms for all family members & guests staying with the RV.

### Camp Guidelines:

- Our site is located in the paved parking lot between two school buildings, on 2 drives or across the street on a school parking lot. School dismisses on Fridays at 3:30 and the children will not be allowed to walk or run between the RVs
- Our school's mission is to "educate responsible citizens" so we ask that your behavior be responsible to serve as a model for our students. We want you to enjoy this lovely location and all the fun of a football weekend. For the comfort of the other campers, please refrain from excessive alcohol use, loud music, shouting chants or any behaviors that would disturb other campers or our school's neighbors.

- Pets are welcome but must be kept on a lease & wear an ID tag when outside the RV. Please pick up after your pet and dispose of poop. Please bring a copy of the pet's vaccinations in case someone is bitten.
- Vehicles such as golf carts, motor cycles or scooters that are towed behind your RV can be parked on the street—just a few steps away. No camper under the age of 16 may drive any vehicle.
- Vehicles may not be left from week to week at the campsite since our school's parking lot is in use daily.
- One large dumpster is provided but no toilet facilities are available.
- The Capitol School and its Foundation do not assume any liability or responsibility for property and vehicles if damaged, lost or stolen. RV owners are fully responsible for their vehicles and other property. Tuscaloosa Police regularly patrol Capitol Park.
- Your submitted application and payment shows your willingness and intent to abide by these rules. Failure to meet these standards will result in being asked to leave the campsite and no refund will be given.
- The City of Tuscaloosa runs a bus service for \$1 starting 3 hours prior to the UA game from the **Intermodal Facility** located 6 blocks away at the corner of 6<sup>th</sup> St. and 23<sup>rd</sup> Ave.

**Release from Liability & Acknowledgment of Assumption of Risk & Hazard Involved**

The undersigned does hereby request that he/she be allowed to park an RV and vehicle to camp at the parking lots of The Capitol School located at 2828 Sixth Street, Tuscaloosa, Alabama 35401. Camp sites will be assigned by The Capitol Foundation, a not-for-profit entity.

The undersigned for himself/herself, his/her executors, administrators, heirs and assigns does hereby release and forever discharge The Capitol School and The Capitol Foundation and any other person, partner, firm or corporation, charged or chargeable with liability or responsibility regarding said parking activity, from any and all claims, demands, actions or causes of action, of any and every kind whatsoever, which have, or could hereafter have, on account of, arising out of or in connection with said parking activity on said property.

And further, this Release shall carry with it a full and final release of the above named Capitol School and its Foundation and its Members from any and all liability from any and all claims, demands, chooses of action of every nature and kind, whatsoever, now existing or which may arise, including expenses, service, loss of support and maintenance, mental anguish and any and all other claims directly or indirectly growing out of the undersigned's participation in said parking and related activity and in full of all other claims of any nature occurring prior to, on, or subsequent to the date thereof.

The undersigned further acknowledges the fact that parking recreational vehicles and related activity involves mechanical equipment and is dangerous. Nonetheless, the undersigned desires to participate in such activity with the full knowledge, understanding, and appreciation of the risks and potential injury involved.

The undersigned agrees not to use or allow the use of the premises in any way that interferes with others' use and enjoyment of the camping area or neighboring property, including but not limited to loud music, voices, and equipment. In addition, the under-signed agrees not to use or allow the use of the premises for any illegal activity. If the undersigned breaches any aspect of this provision, he and all of his party will be legally removed from the premises with no refund & forfeit the use of the premises in the future.

This Release and Assumption of Risk Agreement includes members of my family and any guest I might have at my recreational vehicle. I desire to participate and knowingly, freely and voluntarily execute this Release of Liability and Acknowledgement of Assumption of the Risk and Hazard Involved.

IT IS CLEARLY UNDERSTOOD THAT THIS IS A FULL RELEASE OF ALL PRESENT AND FUTURE CLAIMS THAT THE UNDERSIGNED MAY HAVE AGAINST THE CAPITOL SCHOOL AND ITS FOUNDATION BY VIRTUE OF THE CAPITOL FOUNDATION ALLOWING THE UNDERSIGNED TO PARTICIPATE IN PARKING ACTIVITIES.
